1 Registered Training Organisation (RTO)

Sunraysia Institute of TAFE is a Registered Training Organisation (RTO) under the National Vocational Education and Training Regulator Act 2011 to provide nationally recognised training and assessment services and to issue AQF certification documentation for the training products listed on its scope of registration.

The Institute's regulatory body for vocational education and training (VET) and its registration on the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS) is the Australian Skills Quality Authority (ASQA).

The Institute's registration audit was conducted by ASQA in response to an application for renewal of registration and to assess the Institute's ongoing compliance with the VET Quality Framework and the ESOS Framework.

The Institute undertook corrective actions in response to the non-compliances and evidence of rectifications were submitted to ASQA on 16/10/2015 and on 11/1/2015.

The Institute received confirmation from ASQA dated 26/2/2016, that the rectification evidence submitted demonstrates compliance with the VET Quality Framework. Audit Outcome: Compliant

The Institute's registration as a Registered Training Organisation was approved by ASQA for the maximum seven year period to 30 June 2022.

2 Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS)

The Institute's regulatory body for its registration on the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS) is the Australian Skills Quality Authority (ASQA).

The Institute's CRICOS registration has been extended to align with RTO registration to 30 June 2022.

3 Non-School Senior Secondary Education Provider (VCAL)

Sunraysia Institute of TAFE is registered by the Victorian Registration and Qualifications Authority (VRQA) as a non-school senior secondary education provider for the delivery of the Victorian Certificate of Applied Learning (VCAL).

The Institute applied to the VRQA in February 2020 for re-registration as a provider of:

- VCAL Foundation
- VCAL Intermediate
- VCAL Senior

The VRQA undertook a desk-based assessment of evidence provided by SuniTAFE against the Minimum Standards for Registration to Provide an Accredited Senior Secondary Course.

The assessment identified non-compliances in the following areas:

- Standard 3 Student welfare
- Standard 5 Teaching and Learning
- Standard 6 Governance and Probity

The Institute undertook corrective actions in response to the non-compliances and evidence of rectifications were submitted to the VRQA.

On the 9th September 2020 the VRQA advised that the Institute met the requirements of the re-registration process, and registration was granted by the VRQA until 31 December 2025.
